Methodology

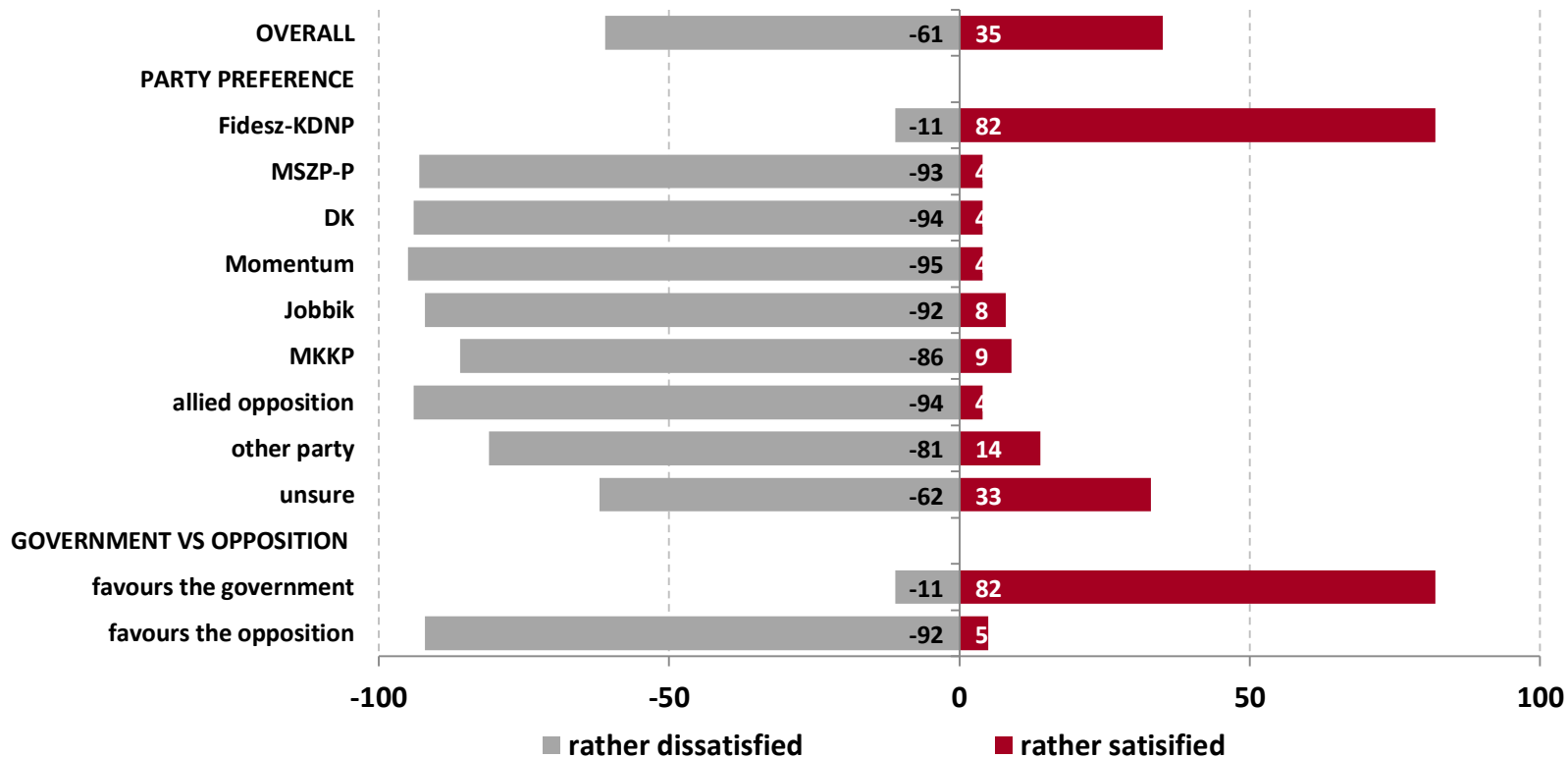
- Telephone and online survey– **2020. december 12-19.**
 - The responders answered the questions to our **surveyors** on the phone.
 - The sample consists of **2499** individuals.
 - The database we set up as a result is representative of the **age, sex, and educational attainment of the Hungarian adult population.**
 - The overall **sampling error is +/- 1,96 percentage points.**
 - Only the socio-demographic breakdowns showing **significant differences** have been displayed
-
- By **“allied opposition voters”** we mean those who would only vote to a **full opposition alliance, but not to any of its component parties individually.**

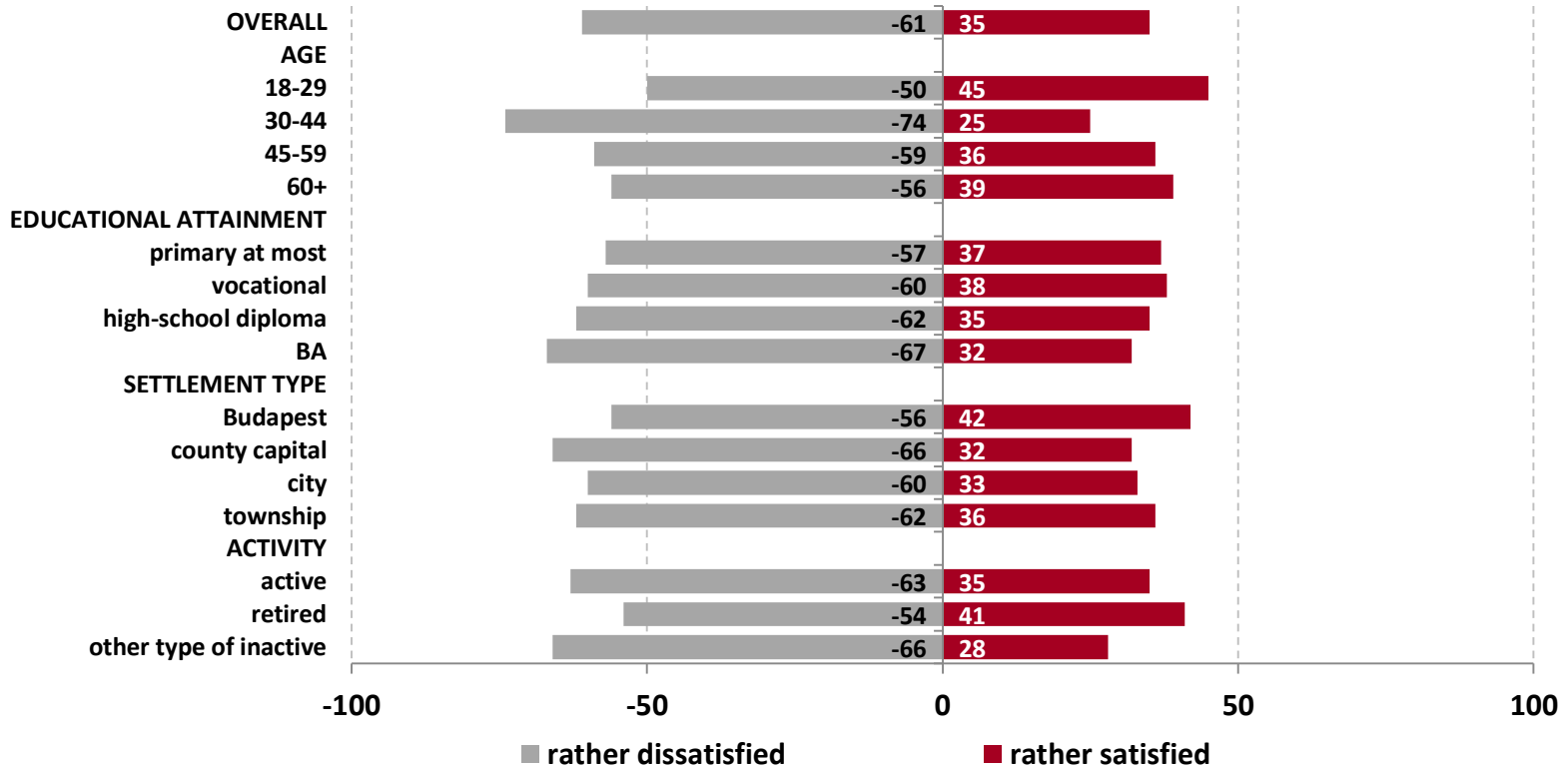
How satisfied are you with the state of the national healthcare system overall?

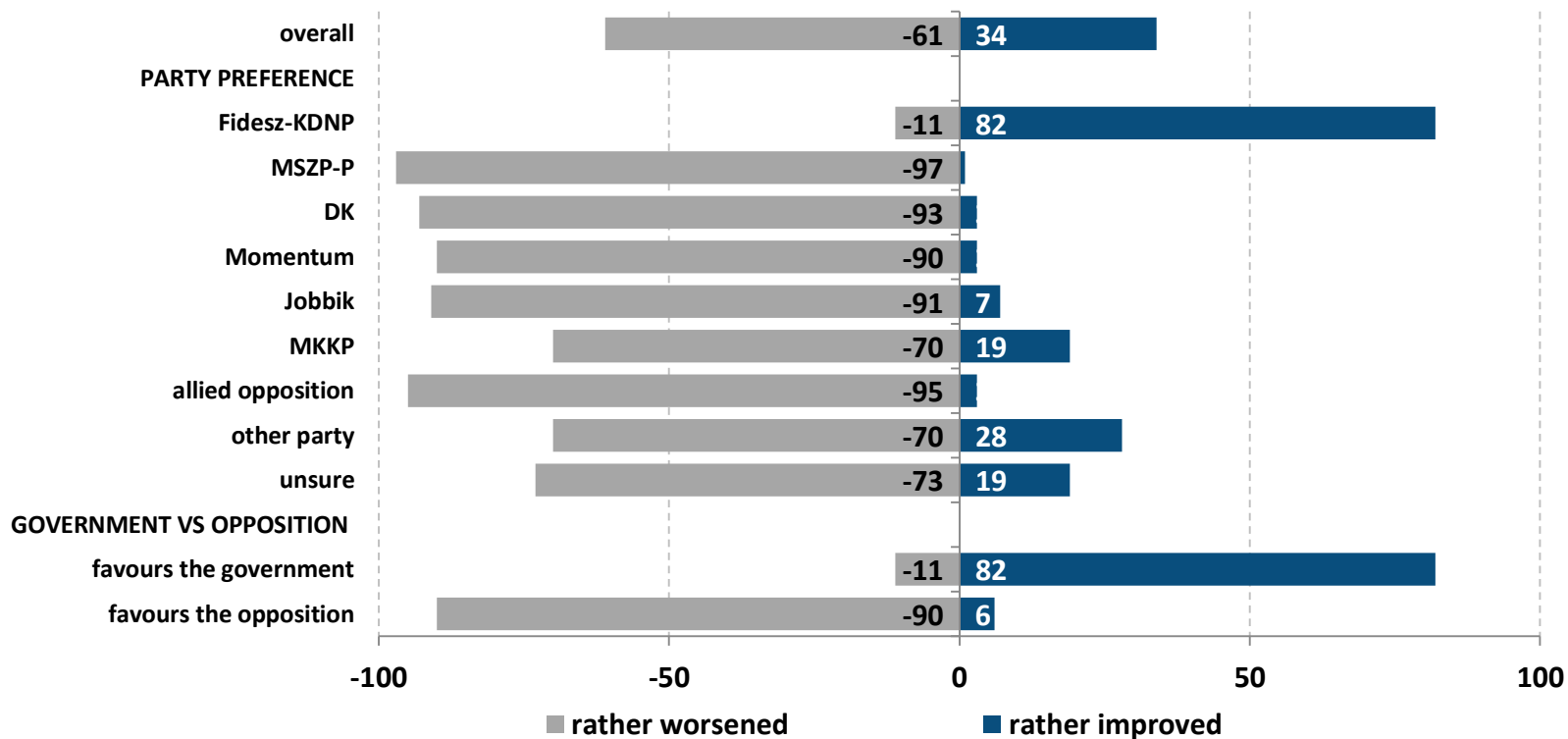
How satisfied are you with the state of the national healthcare system overall?

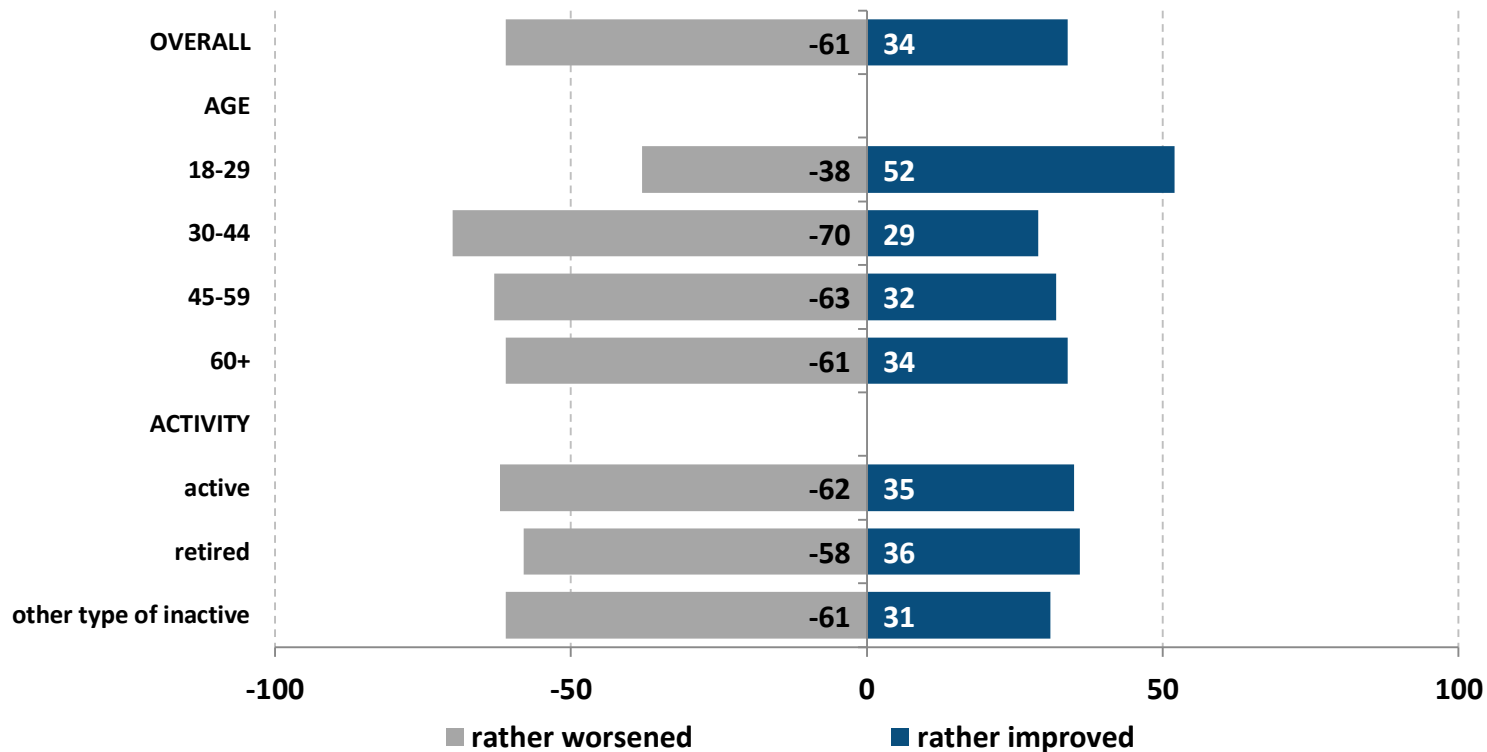
In your opinion, has it (state of the national healthcare system) rather improved or worsened in the recent years?

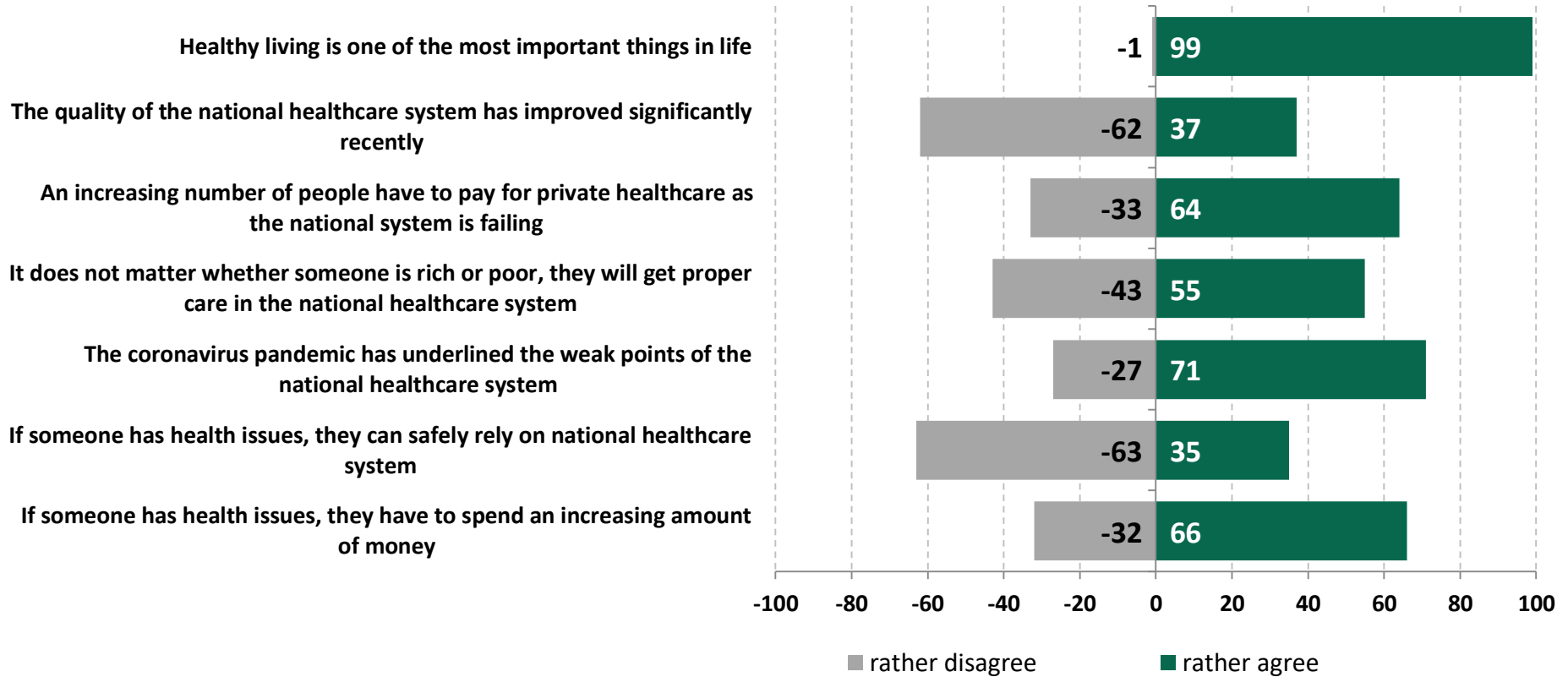


In your opinion, has it (state of the national healthcare system) rather improved or worsened in the recent years?

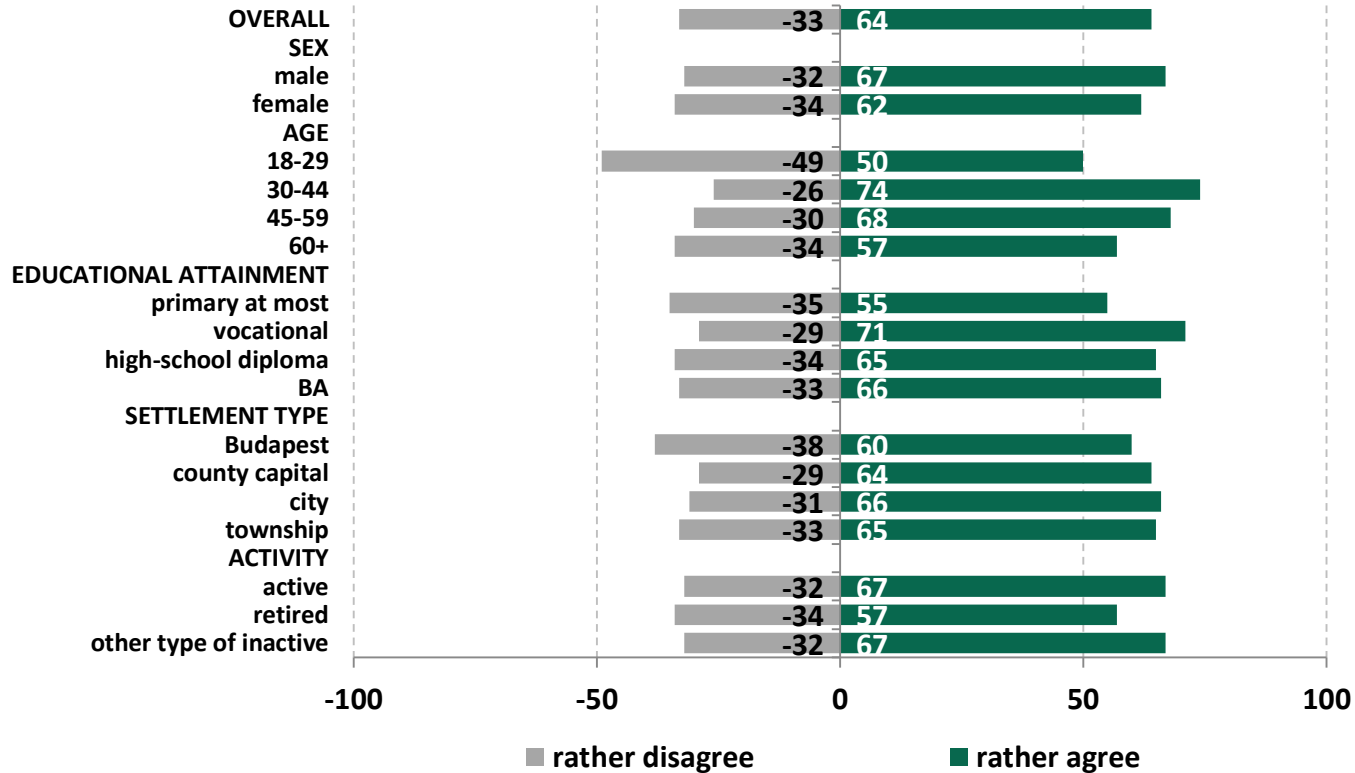

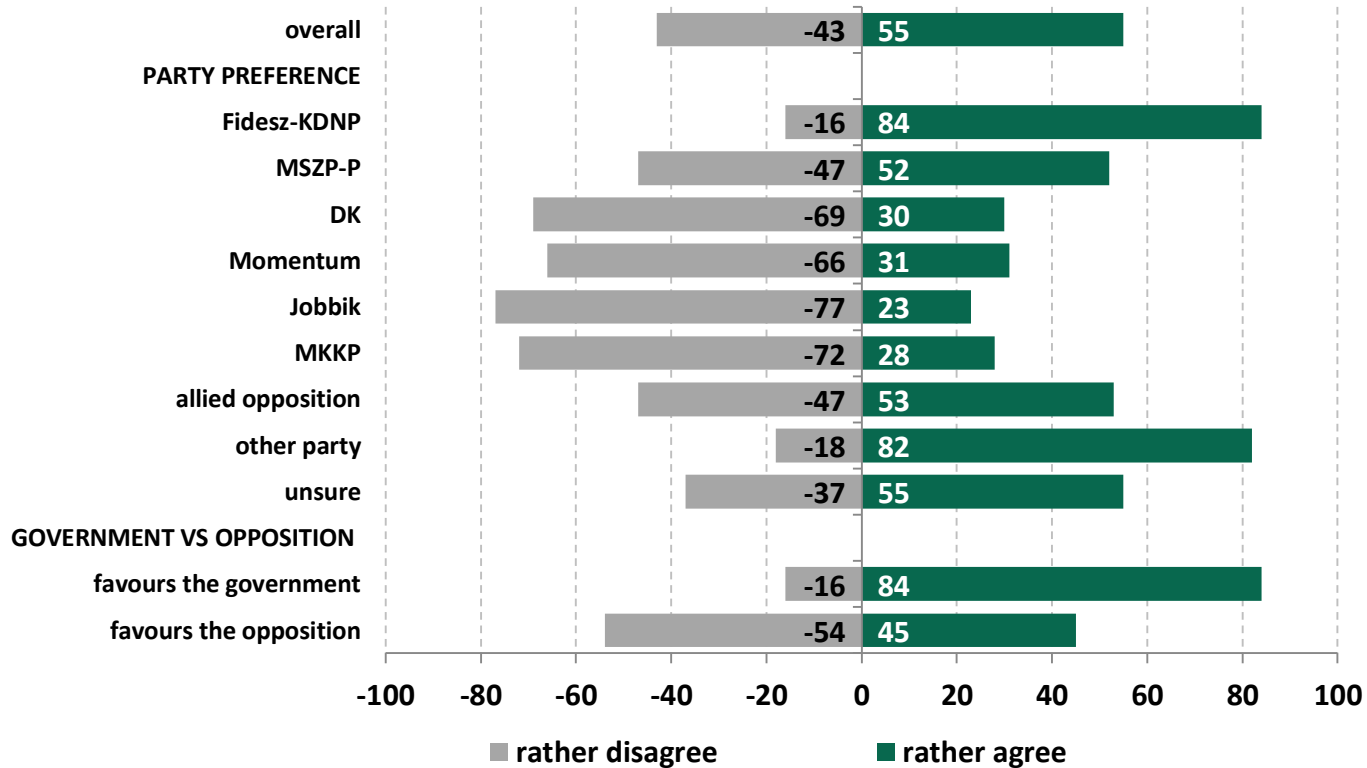
To what extent do you agree with these statements? (All responders, %)



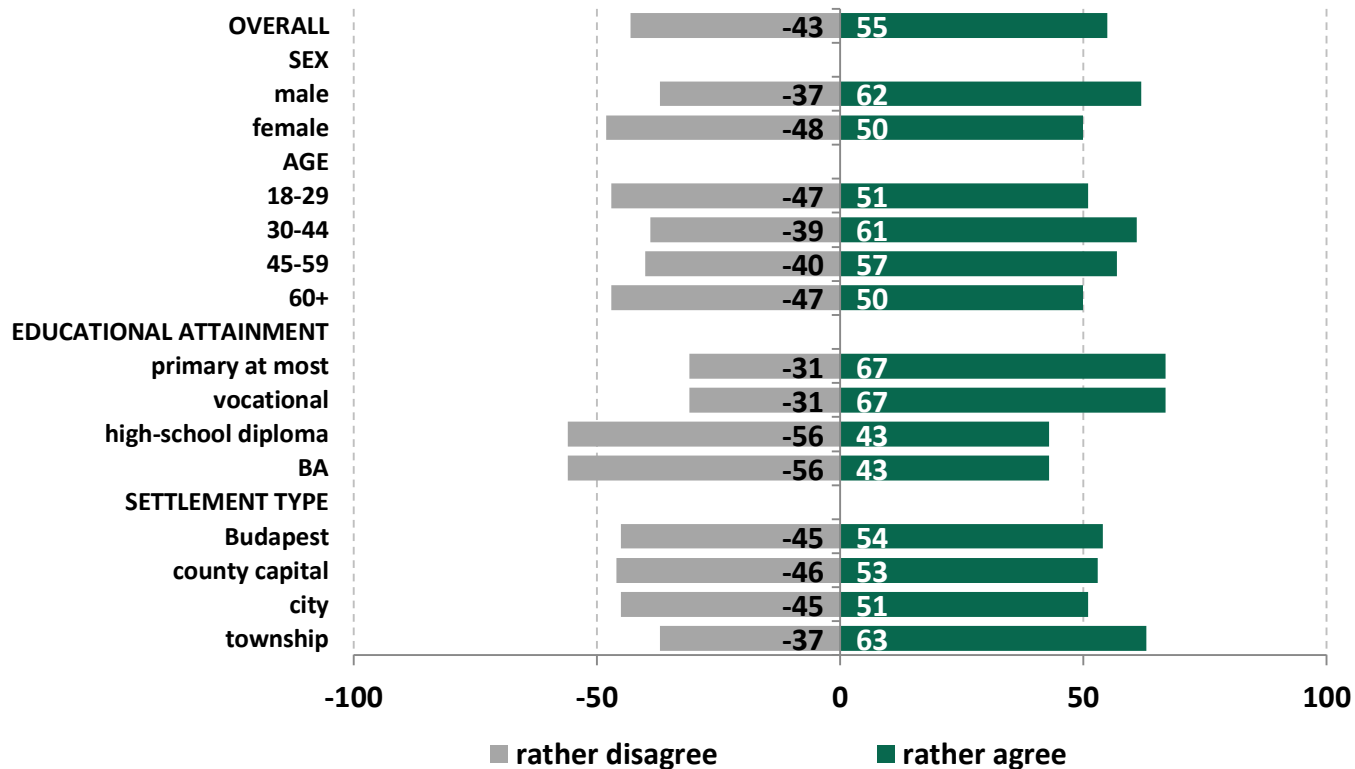
To what extent do you agree: An increasing number of people have to pay for private healthcare as the national system is failing (All responders, %)



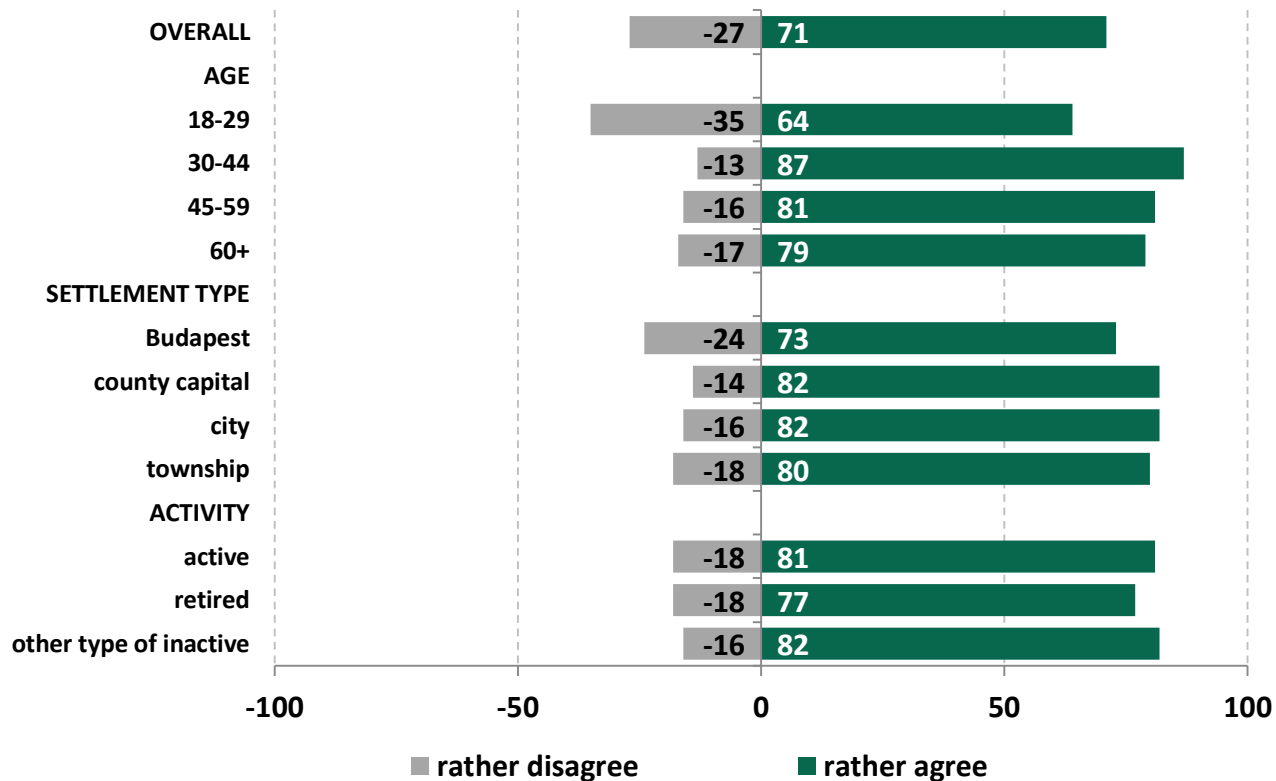
To what extent do you agree: It does not matter whether someone is rich or poor, they will get proper care in the national healthcare system (All responders, %)



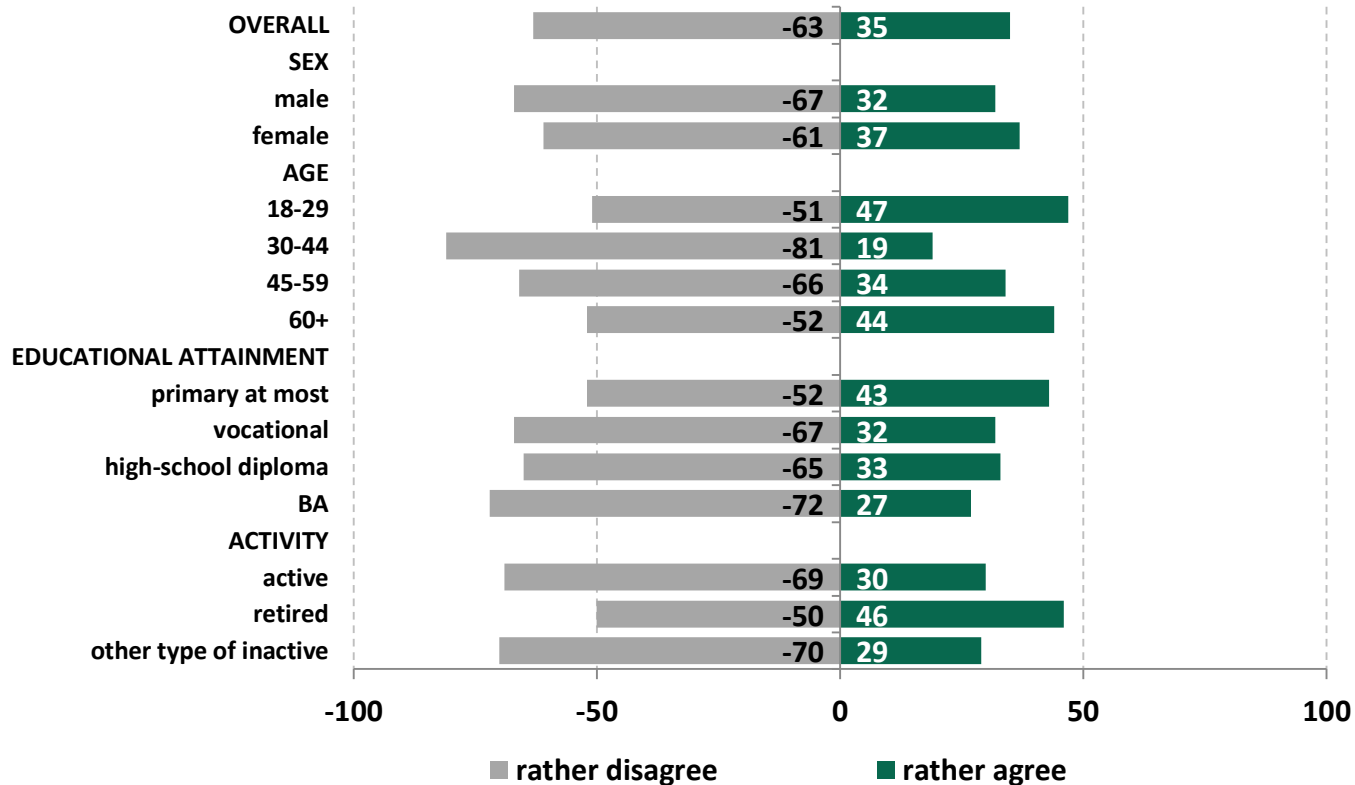
To what extent do you agree: It does not matter whether someone is rich or poor, they will get proper care in the national healthcare system (All responders, %)



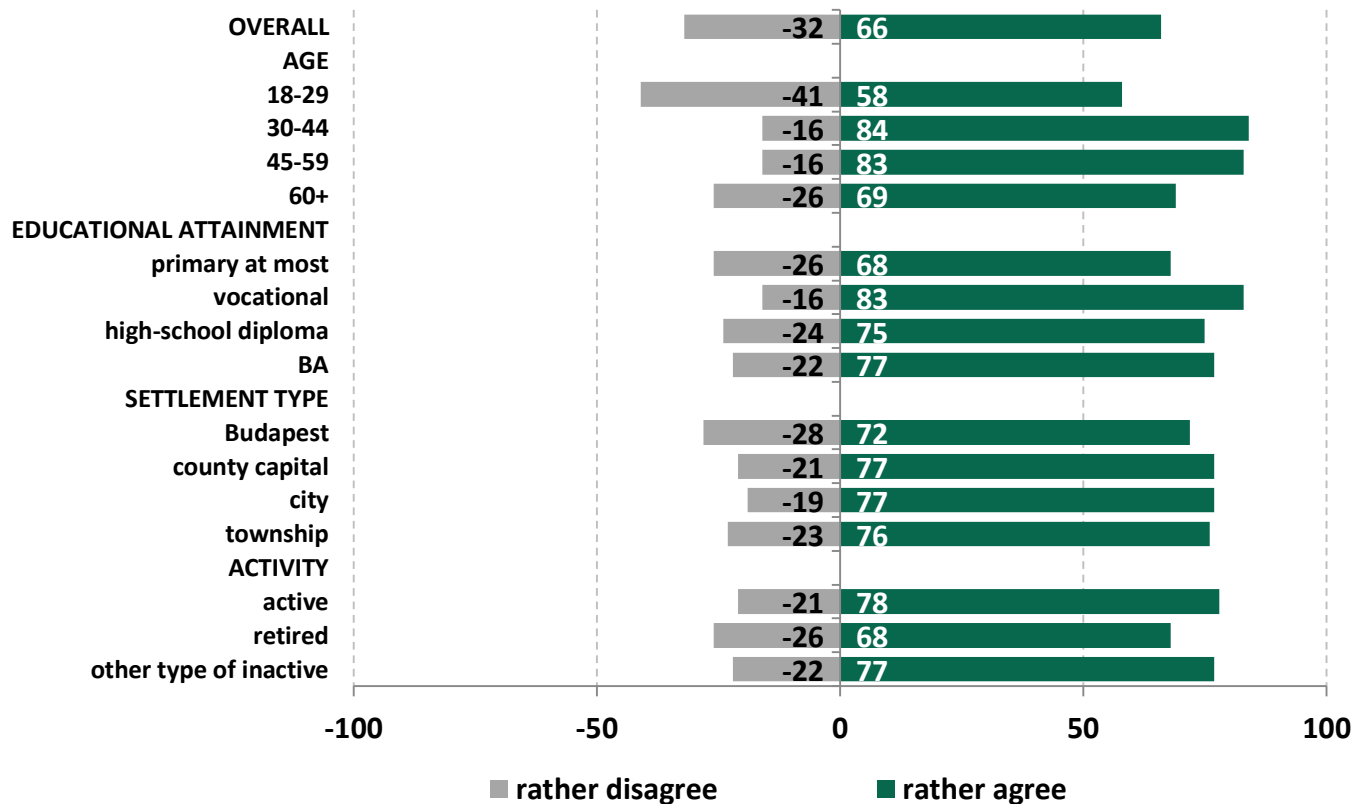
To what extent do you agree: The coronavirus pandemic has underlined the weak points of the national healthcare system? (All responders, %)

To what extent do you agree: **If someone has health issues, they have to spend an increasing amount of money?** (All responders, %)

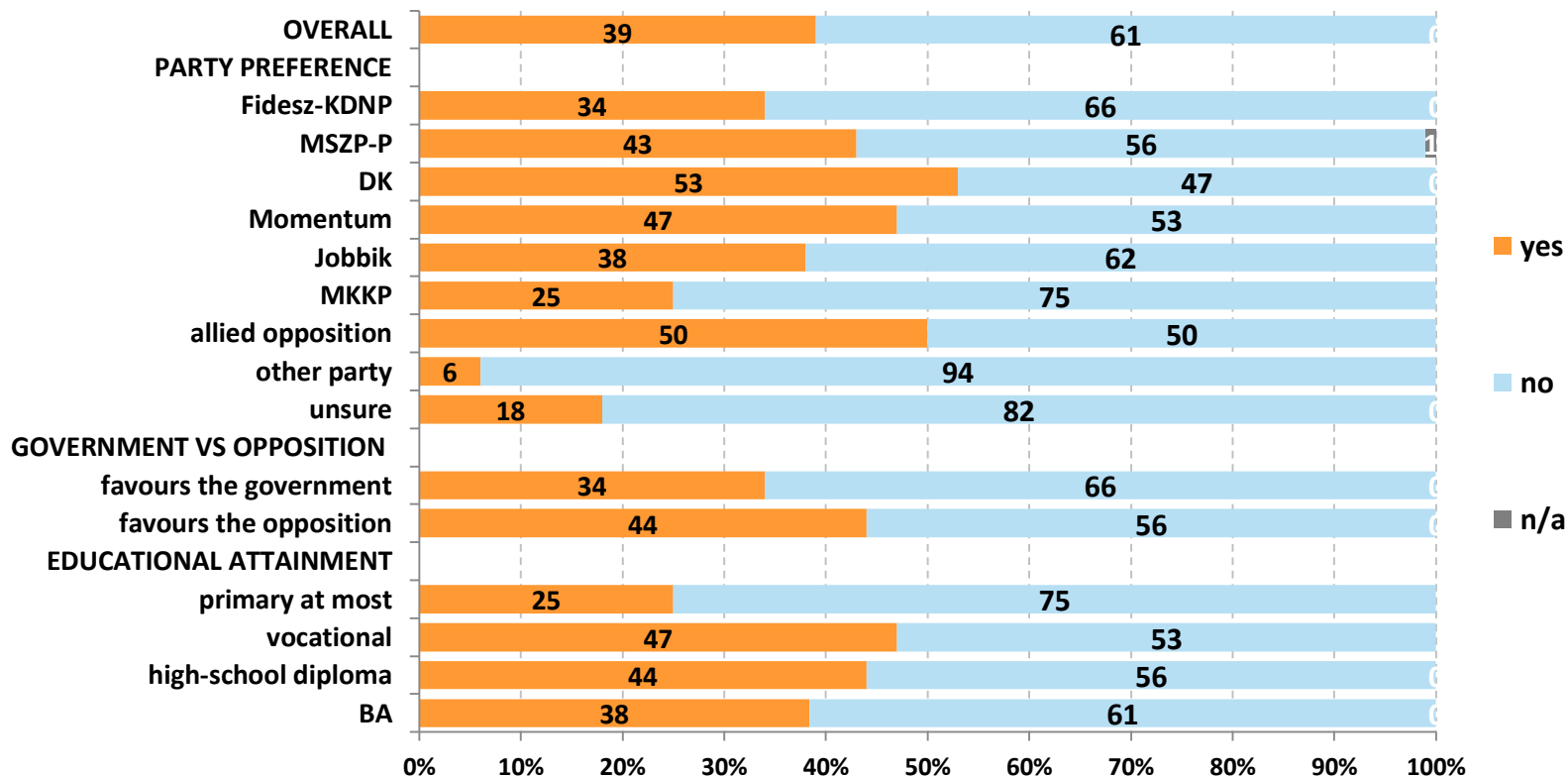




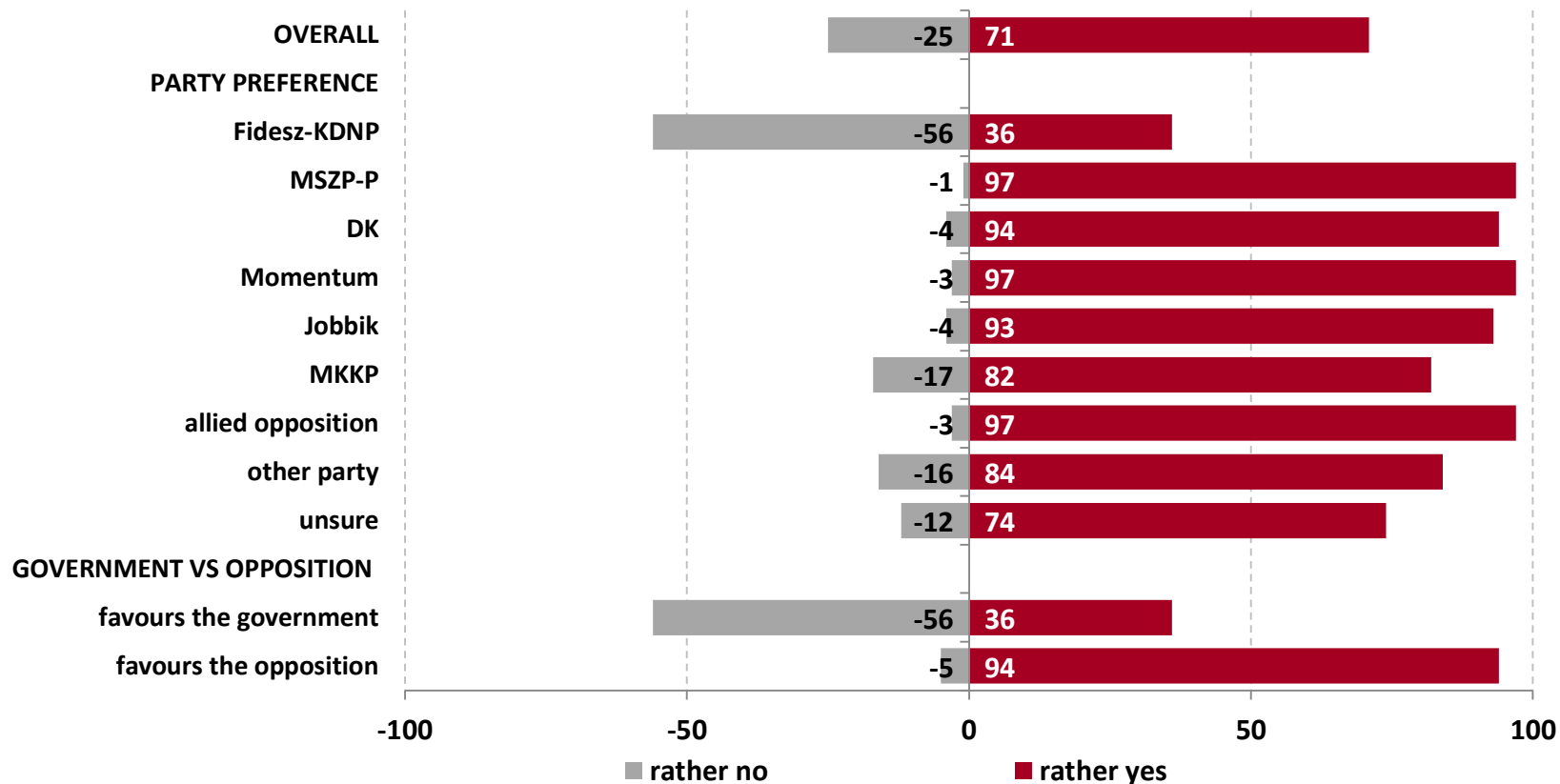

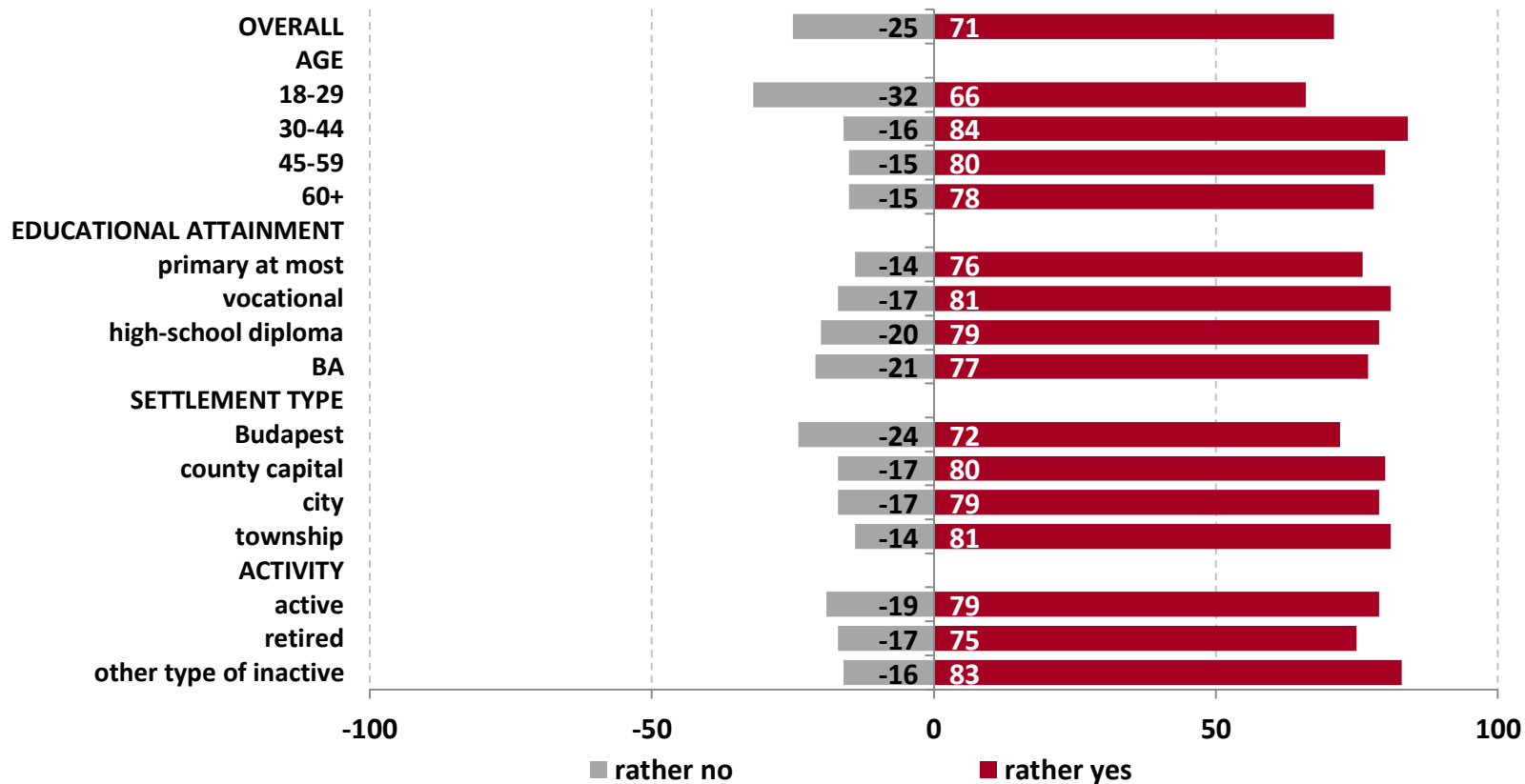

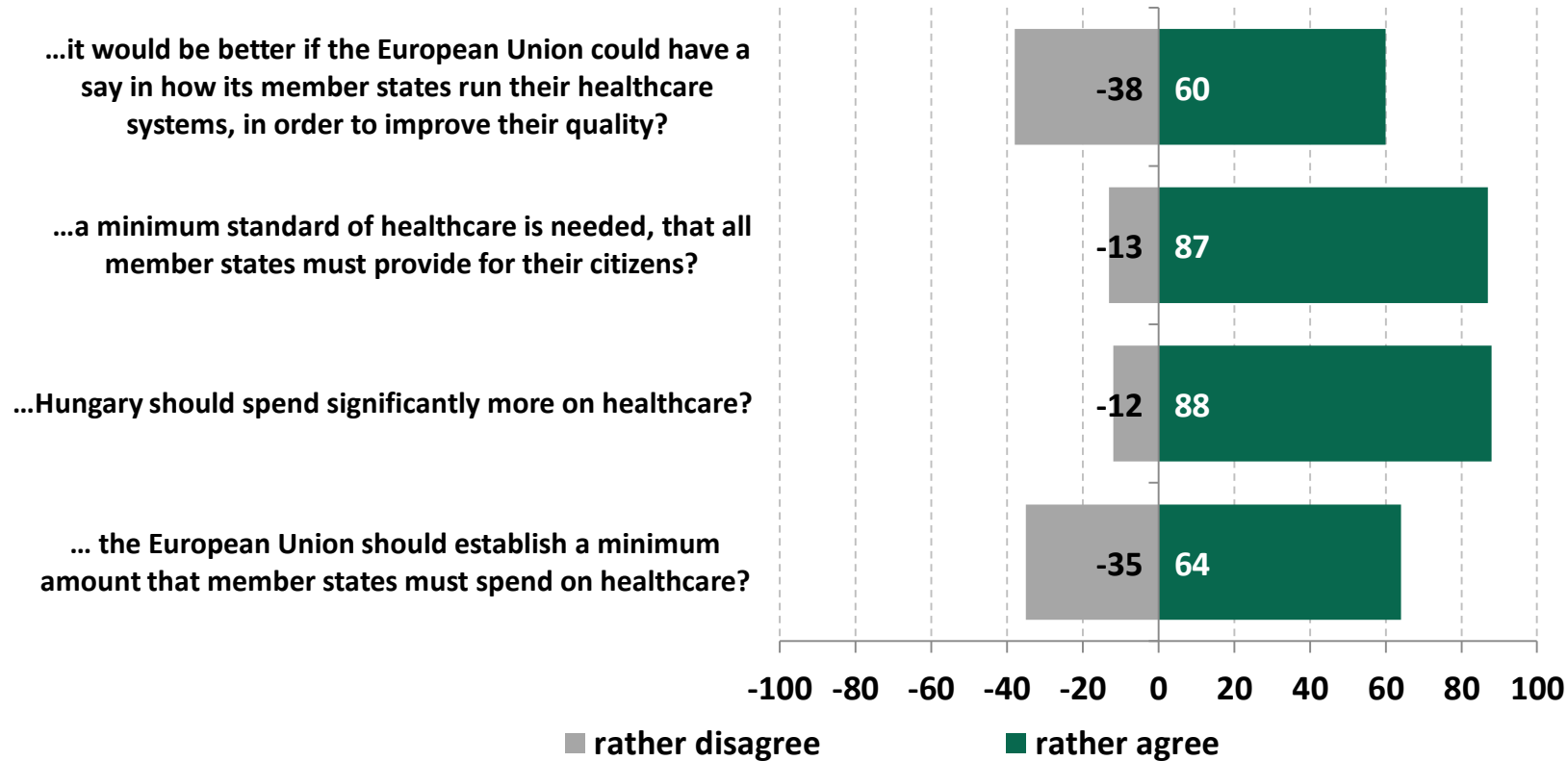
Do you support the creation of the European Health Union? (All responders, %)



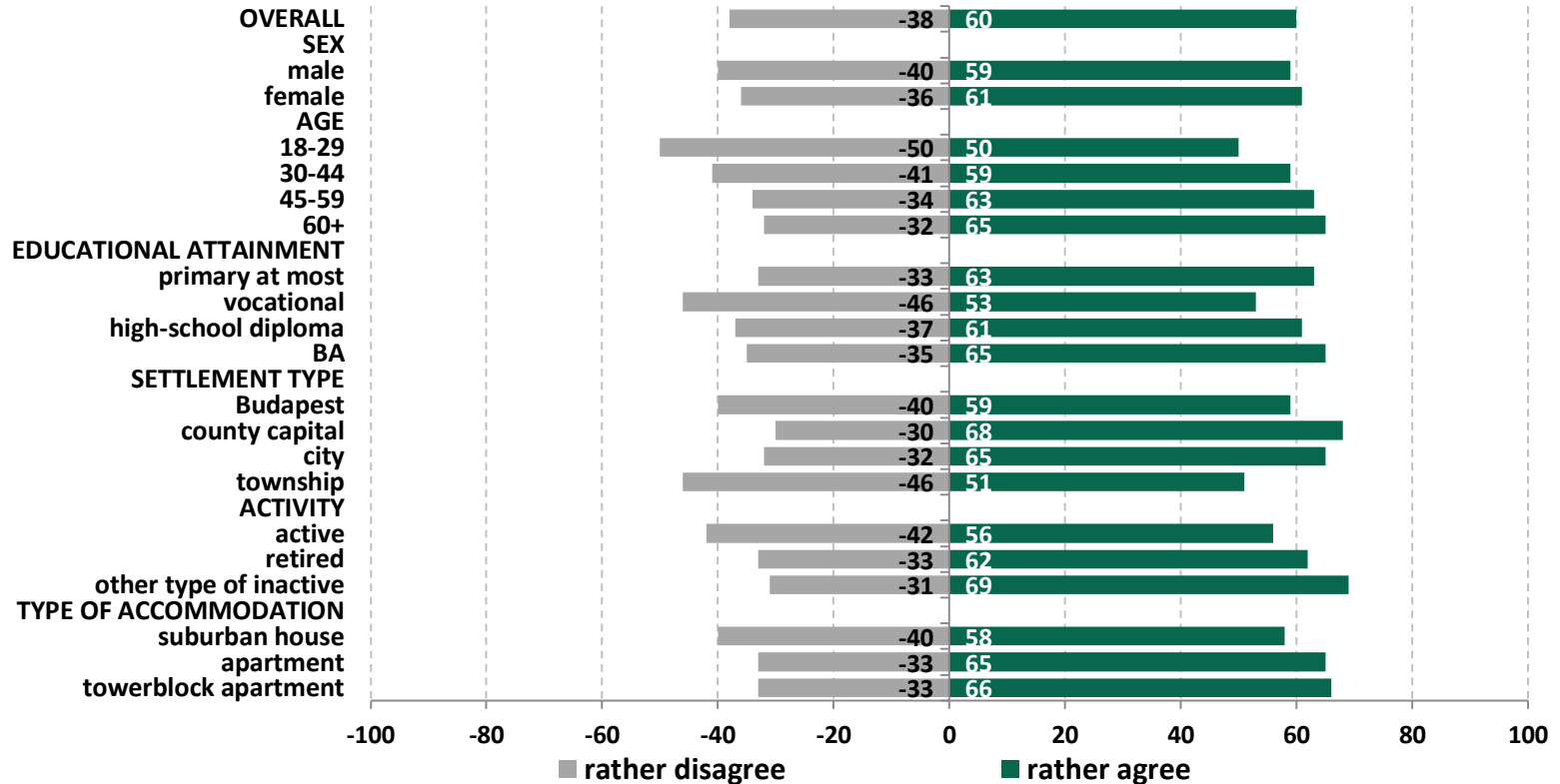

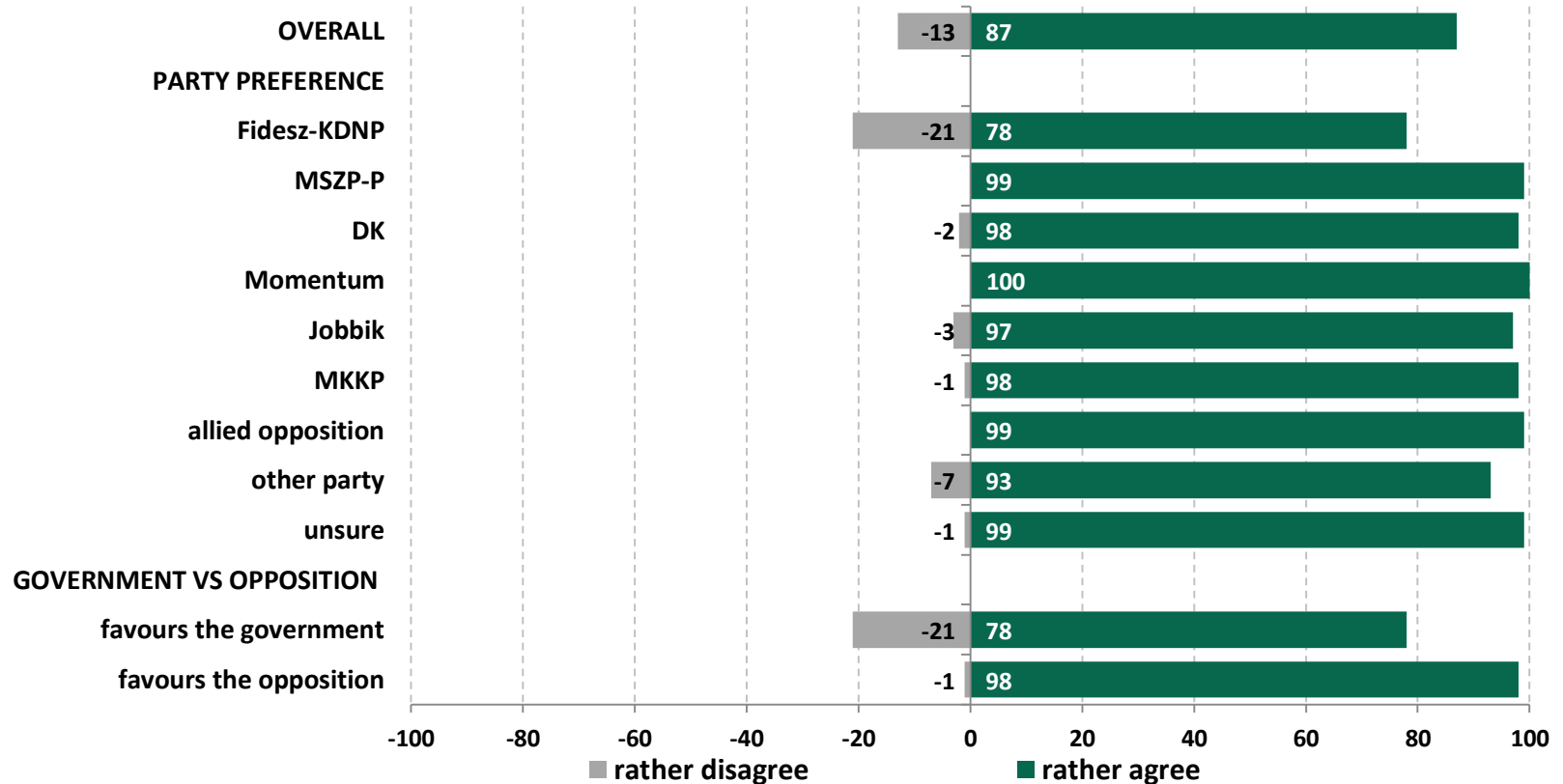

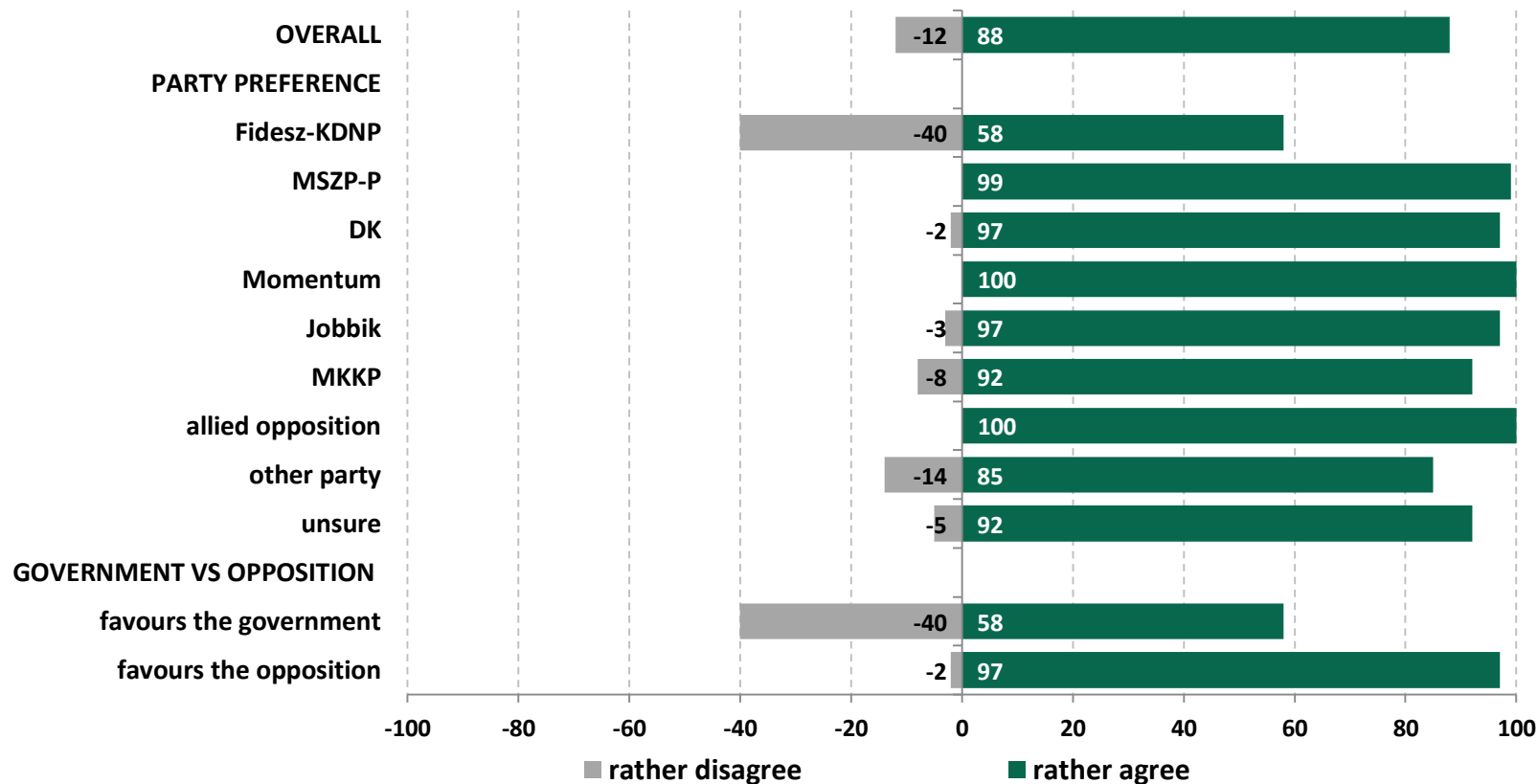
Do you agree that it would be better if the European Union could have a say in how its member states run their healthcare systems, in order to improve their quality? (All responders, %)



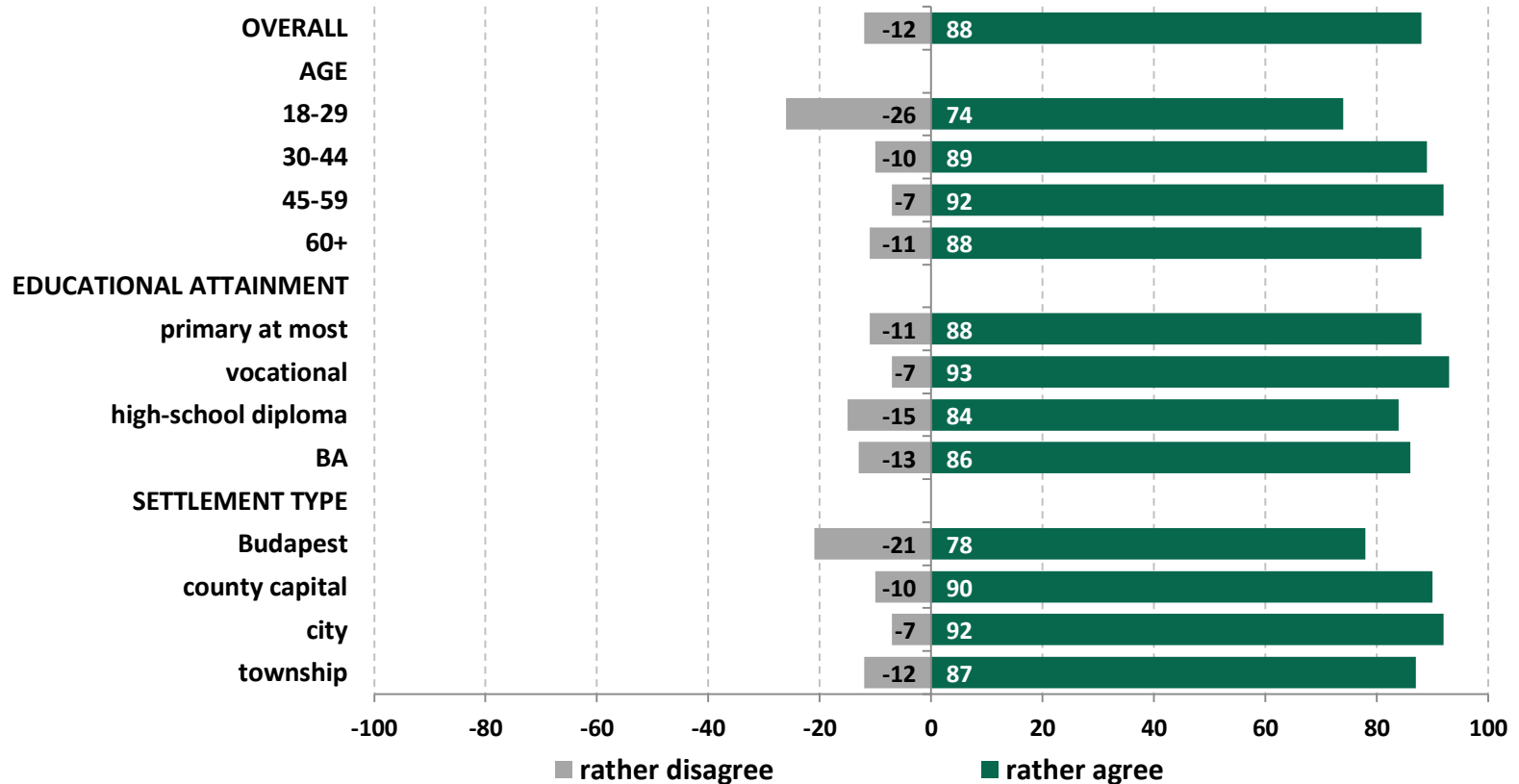
Do you agree that a minimum standard of healthcare is needed, that all member states must provide for their citizens? (All responders, %)



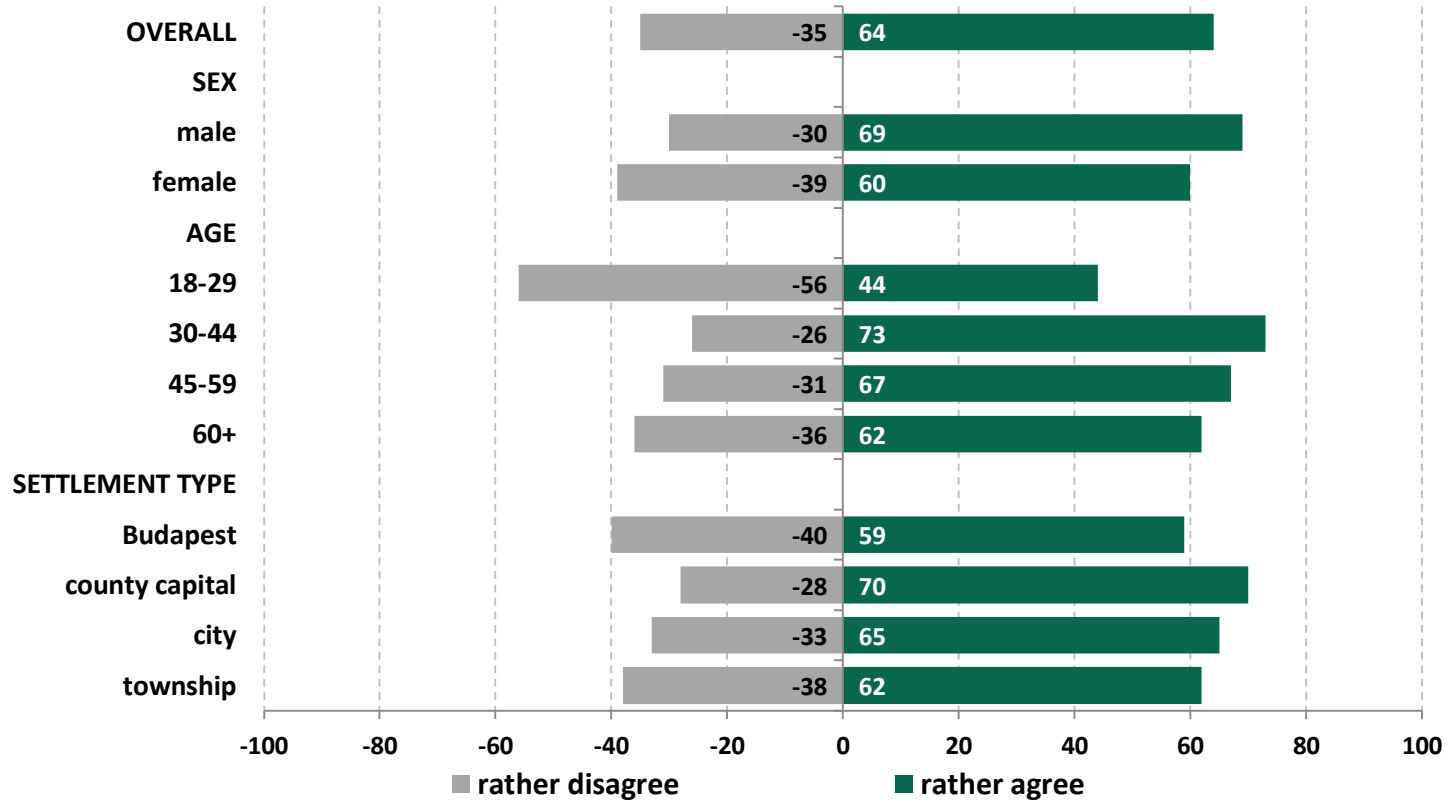
Do you agree that Hungary should spend significantly more on healthcare? (Overall, %)



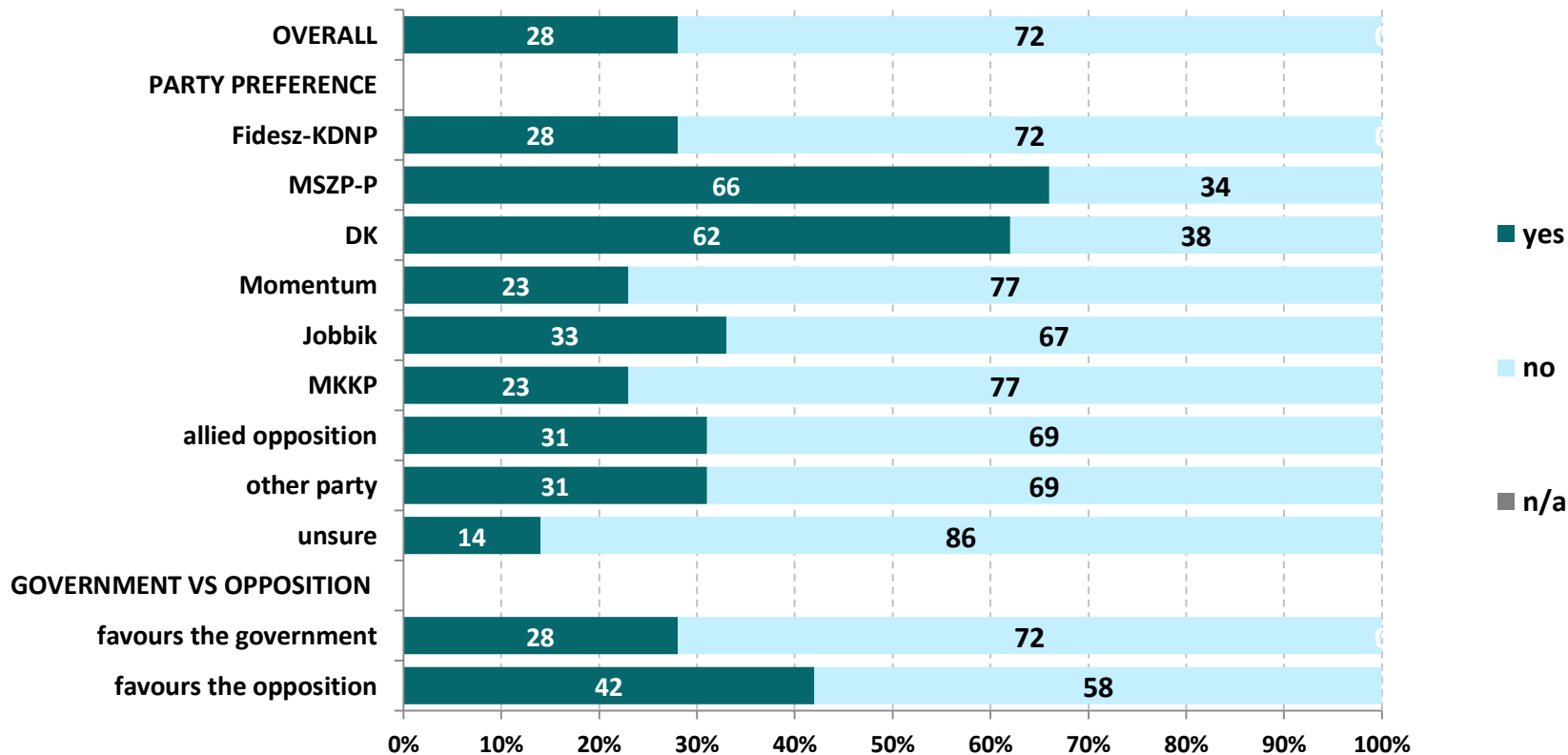

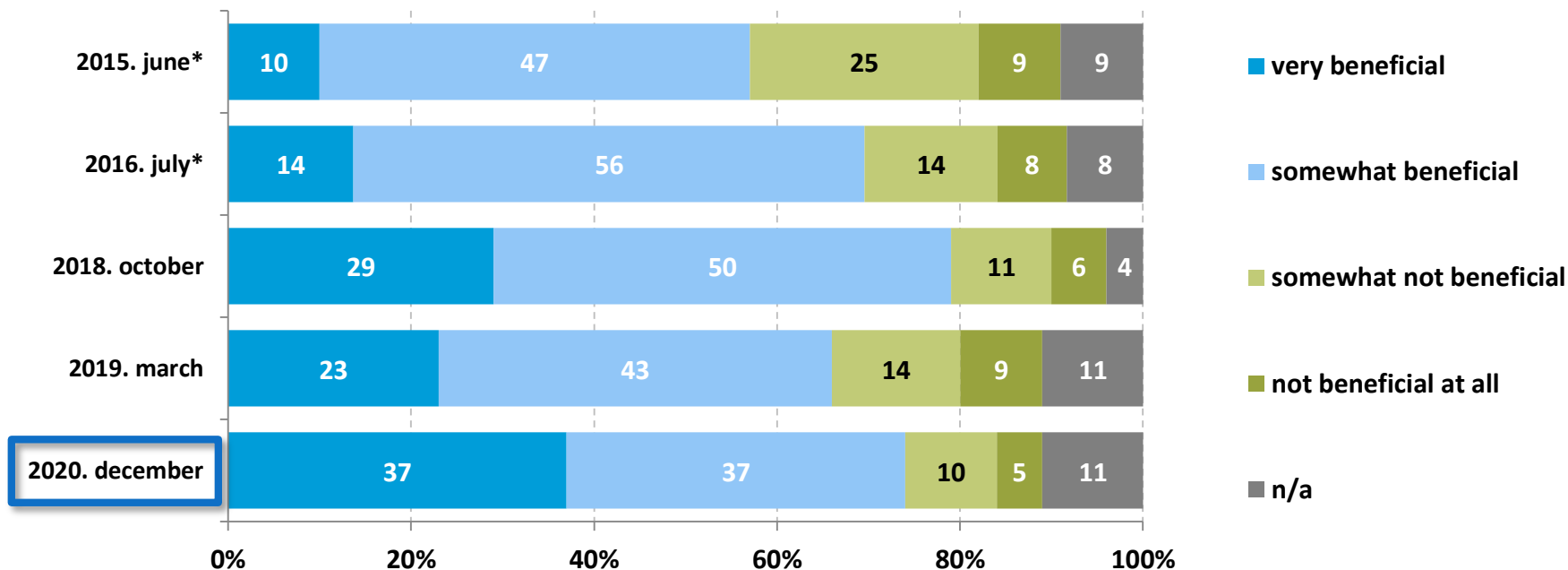

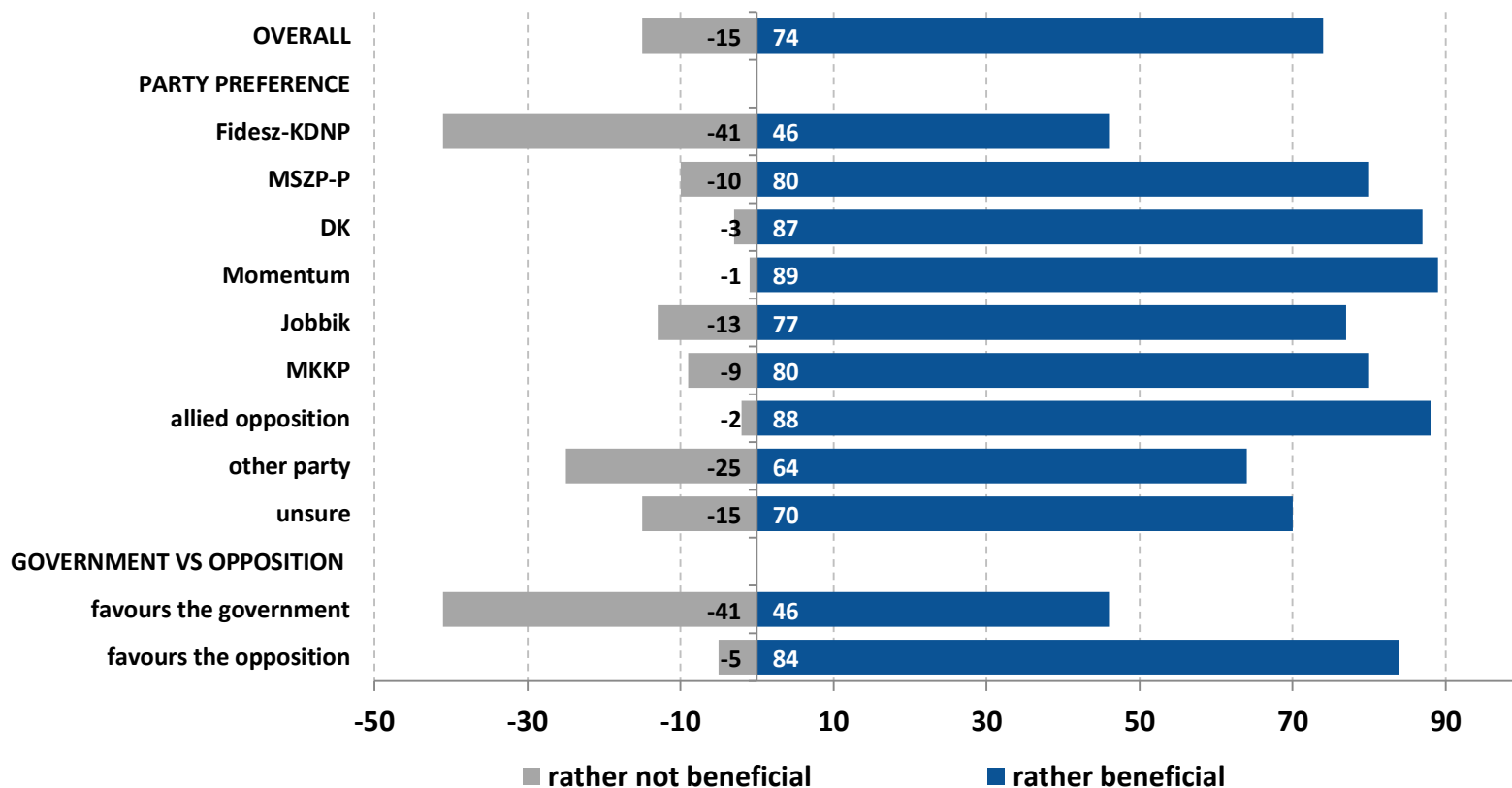
In your opinion, the EU membership for Hungary so far has been::

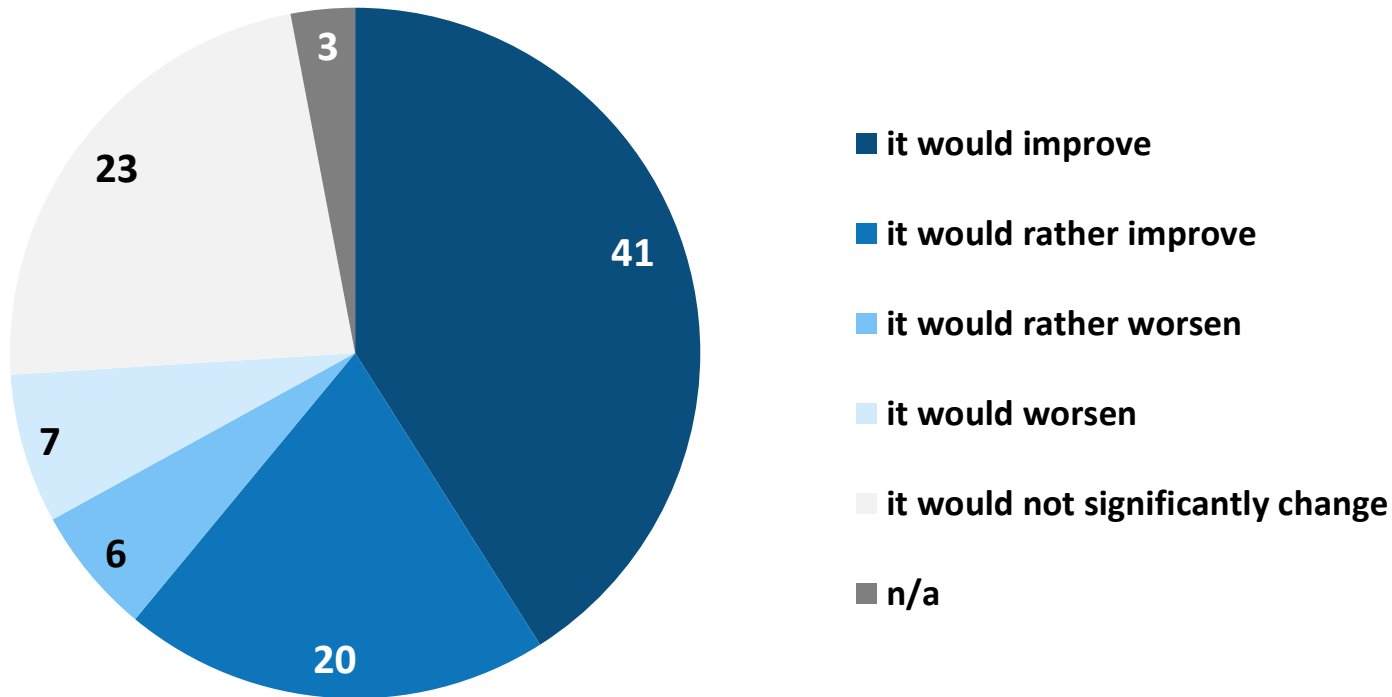

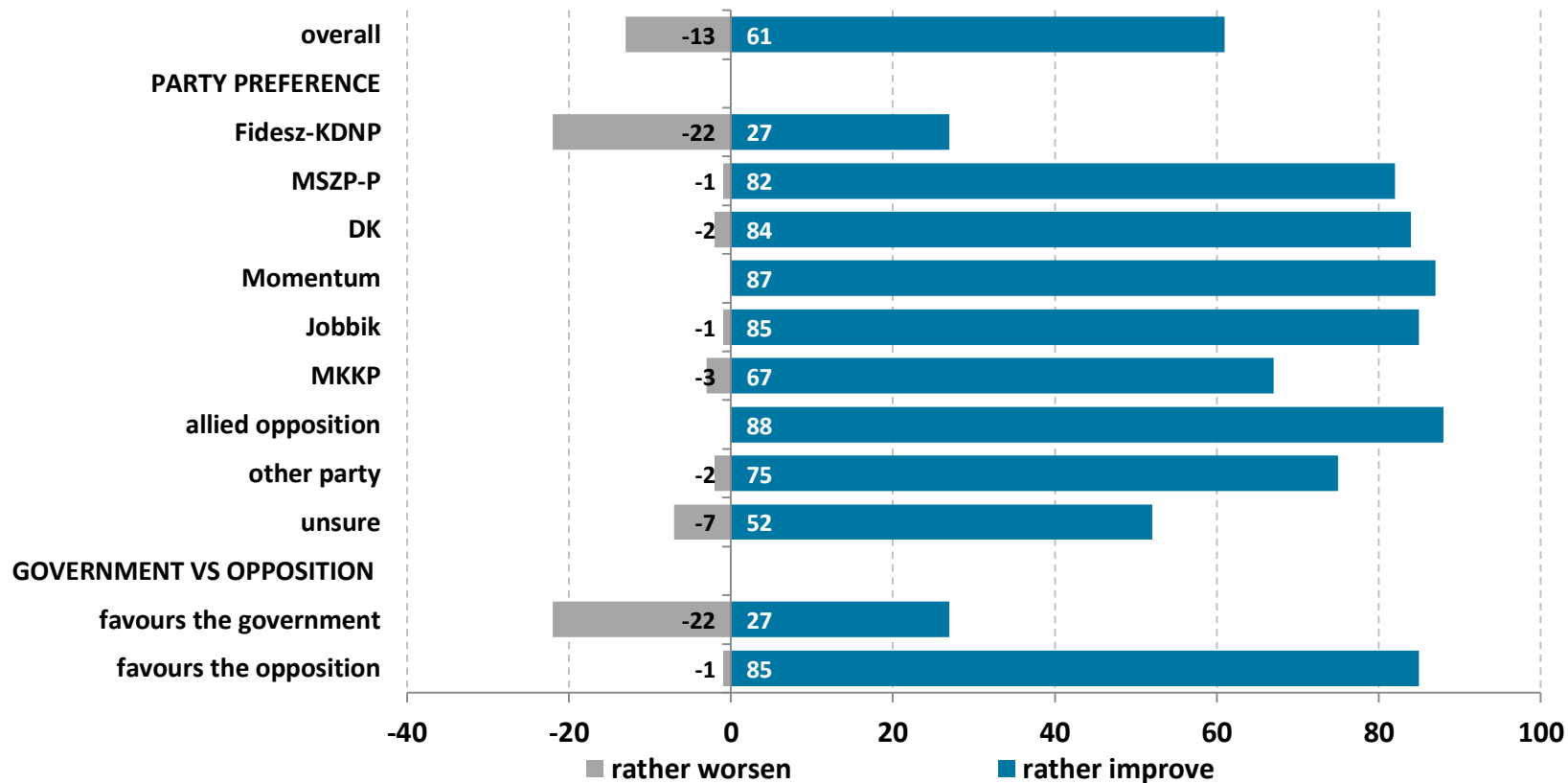

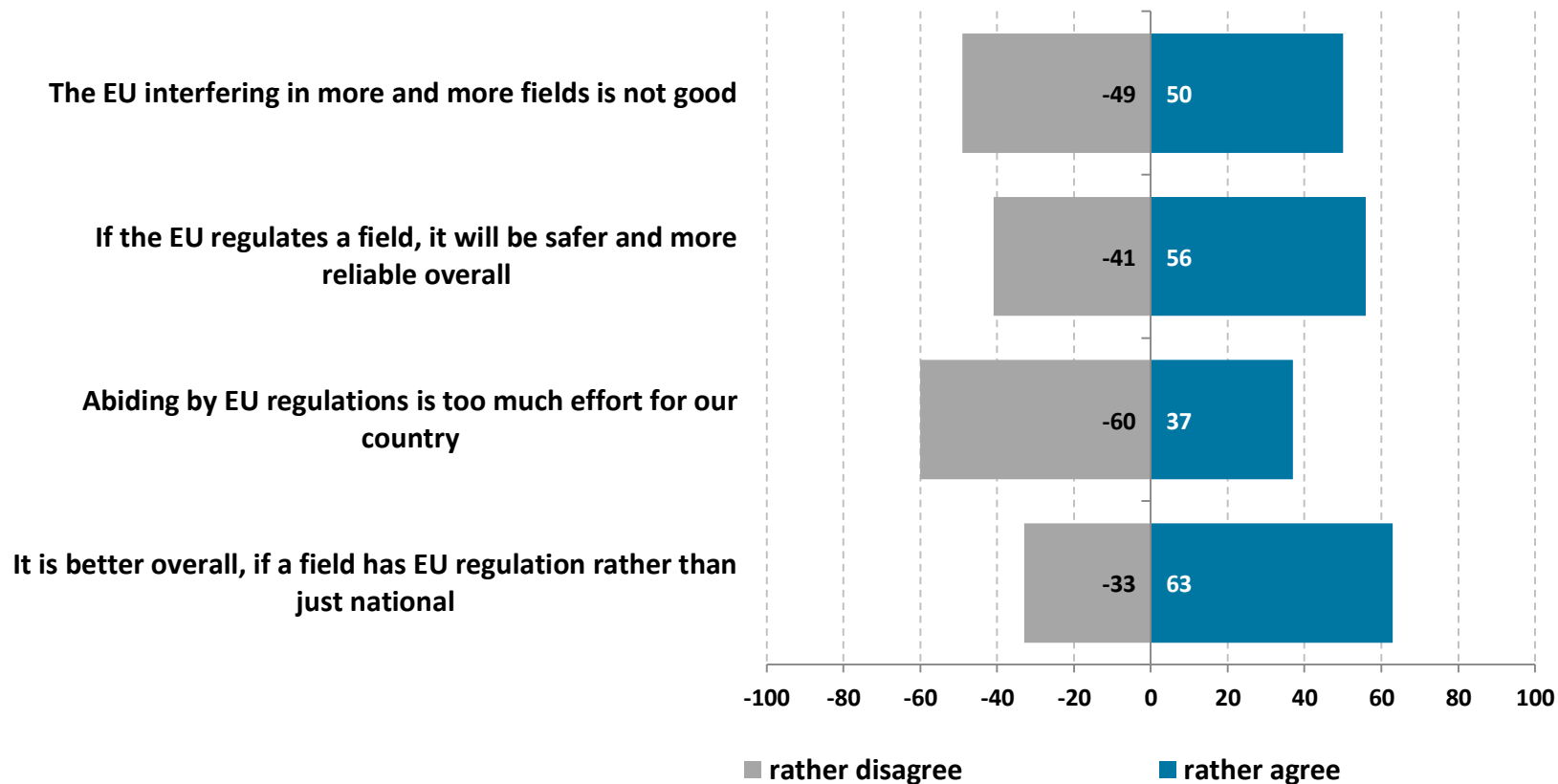

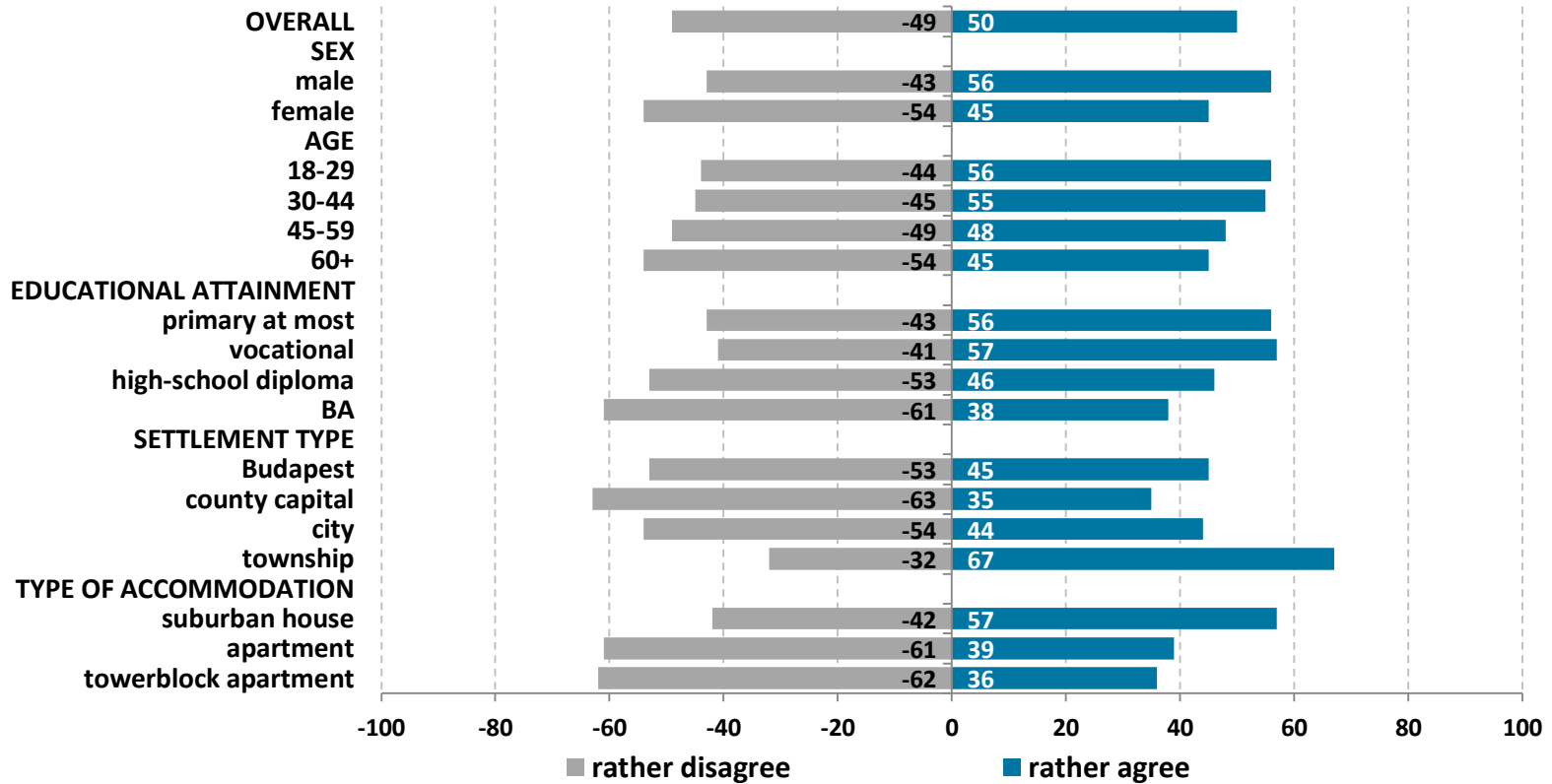

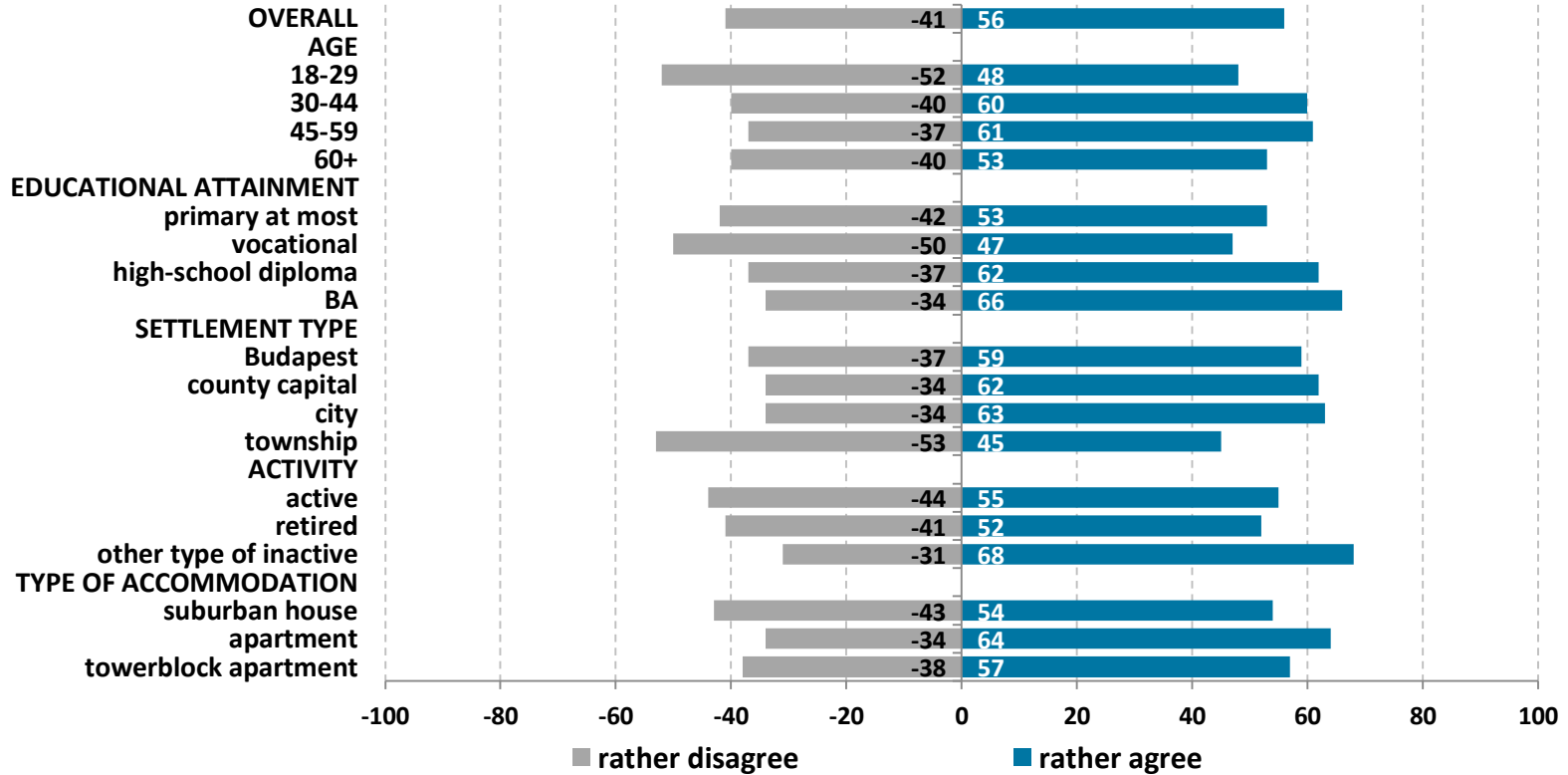

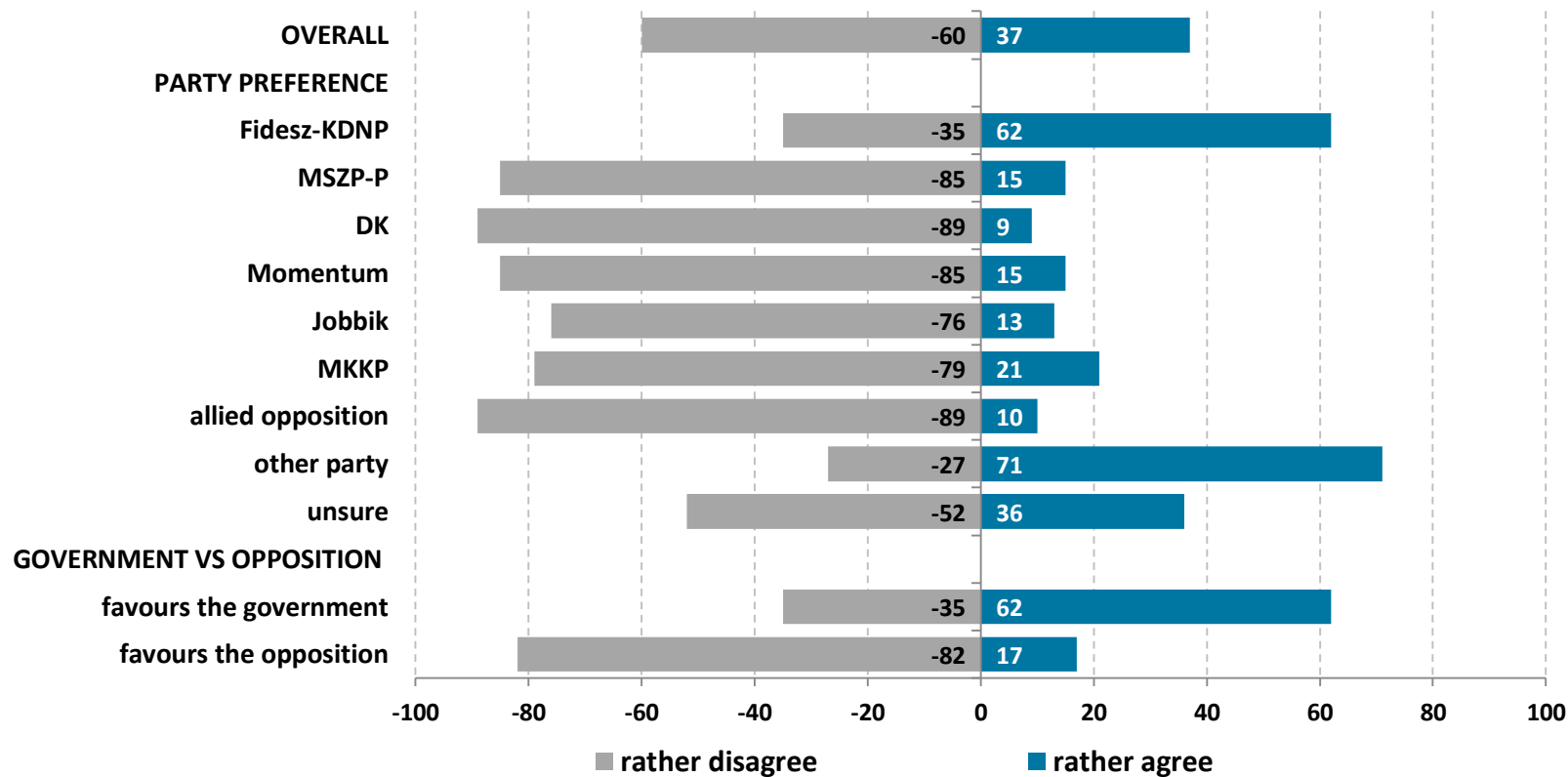
Do you agree with the following: **The EU interfering in more and more fields is not good** (All responders, %)
